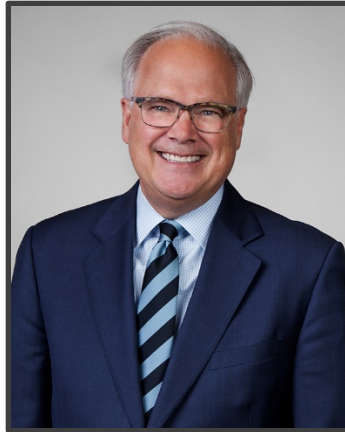

Brewers' Stadium crane collapse, 7 weeks), accounting malpractice (5 weeks), product liability-agricultural equipment (5 weeks), tortious interference/defamation (4 weeks) and chemical exposure (2 weeks). His appellate experience includes multiple oral arguments before the Wisconsin Supreme Court and intermediate appellate courts.

In addition to a full legal practice and serving as a Marquette Law School adjunct Trial Advocacy Professor (where he has taught Trial Advocacy for 20 years), Mr. Weber has been active as a community supporter. He has founded and worked with several educational, charitable and nonprofit groups, including the Marquette University National Alumni Board, the Board of the Wisconsin Conservatory of Music, the Marquette University College of Arts & Sciences Alumni Board, and the FC Milwaukee Soccer Club.

Mr. Weber serves as a member of the Northwestern Mutual Board of Trustees, the Board of the Wisconsin Center for Investigative Journalism, the Board of Frank Beverage Companies and the National Board for Rocketship Education, a San Jose-based network of public elementary charter schools serving primarily low-income students.

Mr. Weber graduated from Columbia University Law School where he served on the Law Review. He then clerked for the Hon. Richard D. Cudahy, United States Court of Appeals for the Seventh Circuit. His undergraduate degree is from Marquette University where he studied history and philosophy, graduating summa cum laude and becoming a member of Phi Beta Kappa.
